GENERAL PROVISION

- D. Income from a person who is or during the past twelve months was registered or was required to be registered as a municipal lobbyist or lobbying firm pursuant to the L.A.M.C. Section 48.01 et seq., with respect to advocacy before the El Pueblo de Los Angeles Historical Monument Authority or officers and employees of the Department.

- D. Any income from any organization which during the past twelve months attempted to influence any action of the El Pueblo de Los Angeles Historical Monument Authority.
- E. Any investment in, income from, or business positions with any person or business entity engaged in auditing or accounting services.

CATEGORY 4

Any investment in, income from, or business positions with any person or business entity that has within the past twelve months, proposes to, or currently manufactures, distributes, designs or sells equipment, materials, or supplies in the fields of maintenance, landscaping, construction and repairs, and public and employee safety to the El Pueblo de Los Angeles Historical Monument Authority.

CATEGORY 5

- A. Any investment in, income from, or business positions with any person or business entity engaged in the booking of musicians, musical groups or variety acts, or any performer or professional artist who sought or received income through a contract with the El Pueblo de Los Angeles Historical Monument Authority.
- B. Any investment in, income from, or business positions with any person or business entity which engages in the promotion, planning or production of cultural, historic and special events, or commercial filming production.
- C. Any income from any individual who is or during the past twelve months was employed under the supervision of the filer temporarily or permanently, or who applied for such employment.
- D. Any investment in any business entity, or income from any business entity or individual, which provides any service in communications media.
- E. Any investment in, income from, or business positions with any person or business entity that has within the past twelve months, proposes to, or currently participates in department-sponsored grant funded programs.
