

**GENERAL PROVISION**

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

**CATEGORY 1**

Any investment, interest in real property located within the City of Los Angeles, or income, as defined in this Code.

**CATEGORY 2**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, services, manufactures, retails or wholesales fire safety equipment, tools, apparatus, protective clothing, or supplies designed for use by fire protection agencies, public or private.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides job safety educational services.

**CATEGORY 3**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, manufactures, sells, installs or services fire protection systems or equipment.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides consulting services concerning fire protection systems.
- C. Any investment in, income from, or employment or management position with any person or business entity which is engaged in building construction contracting or subcontracting, or which supplies equipment used in the construction of major facilities in the City of Los Angeles.
- D. Any investment in, income from, or employment or management position with any person or business entity whose occupancies are inspected for fire and life safety hazards or requirements. Occupancies include, but are not limited to public assemblage occupancies, industrial and commercial occupancies, high-rise units, bars, schools,

churches, hotels, institutions, public events facilities, restaurants, theaters, nightclubs day care and residential facilities.

- E. Any investment in, income from, or employment or management position with any person or business entity engaged in motion pictures and television production or filming and who is an applicant or who has been approved a permit for filming on location within the jurisdiction as defined by this Code by the Entertainment Industry Development Corporation of Southern California.

**CATEGORY 4**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, manufactures, sells, installs or services fire protection systems or equipment.
- B. Any investment in, income from, or employment or management position with any person or business entity which stores, handles, processes, or disposes of hazardous materials and chemicals.
- C. Any investment in, income from, or employment or management position with any person or business entity which is engaged in the manufacture of hazardous chemicals, substances or materials and were issued a permit by the Fire Department within the last twelve months or where the issuance of a permit is pending.
- D. Any investment in, income from, or employment or management position with any person or business entity which provides consulting services concerning fire protection systems.

**CATEGORY 5**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, manufactures, sells, installs or services fire protection systems or equipment.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides consulting services concerning fire protection systems.

**CATEGORY 5** (cont'd)

- C. Any investment in, income from, or employment or management position with any person or business entity which handles, stores, processes, or disposes of hazardous materials and chemicals.
- D. Any investment in, income from, or employment or management position with any person or business entity whose occupancies are inspected by the Fire Department for fire and life safety hazards or requirements. Occupancies include, but are not limited to public assemblage occupancies, high-rise units, new construction, occupancies undergoing sprinkler retrofit or asbestos abatement, and Regulation No. 4 Certification occupancies.

**CATEGORY 6**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, manufactures, sells, installs or services fire protection systems or equipment.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides consulting services concerning fire protection systems.
- C. Any investment in, income from, or employment or management position with any person or business entity which has submitted building plans for plan checking for fire and life safety compliance or for issuance of permits within the last twelve months or where a plan check or permit is pending.
- D. Any investment in, income from, or employment or management position with any person or business entity which has underground tanks located within the City of Los Angeles.
- E. Any investment in, income from, or employment or management position with any person or business entity which installs, removes, or replaces underground tanks within the City of Los Angeles.

**CATEGORY 7**

- A. Any investment in, income from, or employment or management position with any person or business entity which designs, manufactures, sells, installs or services fire protection systems or equipment.

**CATEGORY 7** (cont'd)

- B. Any investment in, income from, or employment or management position with any person or business entity which provides consulting services concerning fire protection systems.
- C. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases fire and safety equipment.
- D. Any investment in, income from, or employment or management position with any person or business entity which provides engineering or design services to the Metropolitan Transit Authority Metro Rail Project.

**CATEGORY 8**

- A. Any investment in or income from any person or business entity which designs, services, manufactures, retails or wholesales equipment, hardware or software designed for use by fire protection agencies, public or private.
- B. Any investment in or income from any person or business entity which provides educational or consulting services concerning electronic data processing systems.
- C. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells, maintains, or distributes computer systems, data processing hardware and/or software application products or provides computer services.
- D. Any investment in, income from, or employment or management position with any person or business entity which markets computer-based training services or management services.
- E. Any investment in, income from, or employment or management position with any person or business entity which is engaged in contracting or subcontracting, or supplying communications, electronic and telephone equipment used by the Department.

**CATEGORY 9**

- A. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases office equipment.



**CATEGORY 9** (cont'd)

- B. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells, or leases equipment, parts, supplies, or materials used in providing emergency medical services.
- C. Any investment in, income from, or employment or management position with any person or business entity which is engaged in contracting or subcontracting, or supplying materials, tools, uniforms, equipment or fire apparatus used by the Department of Fire.
- D. Any investment in or income from any person or business entity which designs, services, manufactures, retails or wholesales equipment, hardware, or software designed for use by fire protection agencies, public or private.
- E. Any investment in, income from, or employment or management position with any person or business entity which engaged in construction contracting or subcontracting, or supplying equipment used in the construction of fire department facilities and maintenance projects.

**CATEGORY 10**

- A. Any investment in, income from, or employment or management position with any person or business entity which provides specialized educational services for persons preparing for Fire Department civil service examinations administered by the City of Los Angeles.
- B. Any income from any individual who currently is or has been a candidate in the Fire Department's Recruitment Training Class within the twelve past months.

**CATEGORY 11**

- A. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells, maintains, or distributes computer systems, data processing hardware and/or software application products or provides computer services.

**CATEGORY 11** (cont'd)

- B. Any investment in, income from, or employment or management position with any person or business entity which markets computer-based training services or management services.

**CATEGORY 12**

Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases audio, video or photographic equipment.

**CATEGORY 13**

Any investment in, income from, or employment or management position with any person or business entity which is engaged in construction contracting or subcontracting, or supplying equipment used in the construction of fire department facilities and maintenance projects.

**CATEGORY 14**

- A. Any investment in, income from, employment or management position with any person or business entity which manufactures, sells, or leases equipment, parts, supplies or materials used in providing emergency medical services.
- B. Any investment in, income from, employment or management position with any person or business entity which provides emergency medical services.

**CATEGORY 15**

- A. Any investment in, income from, or employment or management position with any person or business entity which acts as a distributor for Los Angeles City Fire Department slides, films, or videos.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides management consulting services.

**CATEGORY 15** (cont'd)

- C. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases office supplies and equipment.
- D. Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases audio, video or photographic equipment.
- E. Any investment in, income from, or employment or management position with any person or business entity which:
  - 1. is engaged in providing accounting or auditing services.
  - 2. currently sells, proposes to sell, or within the past twelve months sold major types of goods or services to the Department of Fire.
  - 3. is engaged in rescue ambulance transportation billing services (e.g. individuals, insurers, government agencies).
  - 4. provides any fire-related services for which revenues are collected or fees are received (e.g. fire permits and tests, rental of Department apparatus).
  - 5. provides grants in connection with Department activities.
  - 6. is engaged in providing cartographic services.

**CATEGORY 16**

Any investment in, income from, or employment or management position with any person or business entity which:

- 1. is engaged in providing accounting or auditing services.
- 2. currently sells, proposes to sell, or within the past twelve months sold major types of goods or services to the Department of Fire.

**CATEGORY 16** (cont'd)

3. is engaged in rescue ambulance transportation billing services (e.g. individuals, insurers, government agencies).
4. provides any fire-related services for which revenues are collected or fees are received (e.g. fire permits and tests, rental of Department apparatus).
5. provides grants in connection with Department activities.

**CATEGORY 17**

Any investment in, income from, or employment or management position with any person or business entity which provides management consulting services.

**CATEGORY 18**

Any investment in, income from, or employment or management position with any person or business entity which manufactures, sells or leases office supplies and equipment.
