SCHEDULE "B"**

GENERAL PROVISION

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

CATEGORY 1

1. Any investment; provided, however, that no investment in a business entity shall be considered an investment solely by reason of the ownership by the business entity of an interest in real property located more than two miles outside the boundaries of the City of Los Angeles.
2. Any interest in real property located within the City of Los Angeles or not more than two miles outside the boundaries of the City.
3. Any income.

CATEGORY 2

Any investment in or income from:

1. Any person or business entity which retails or wholesales office supplies, or office furniture.
2. Any employment agency.
3. Any investment in or income from any institution which provides educational or vocational training and is operated for profit in the City of Los Angeles.

CATEGORY 3

1. Any investment in or income from any person or business entity engaged in auditing, or accounting consulting services.
2. Any income from any organization which currently receives or during the past two years received or applied for any grant or contract reviewed; approved, administered or audited by the Department.

CATEGORY 4

1. Any interest in residential real property located within the City of Los Angeles or not more than one half mile outside the boundaries of the City.
2. Any investment in or income from any person, business entity, or organization which owns (other than by mortgage or deed of trust) or operates residential rental property which is located within the City of Los Angeles.
3. Any investment or income from any person, or business entity which sells or appraises real estate in the City of Los Angeles.

CATEGORY 5

1. Any investment in or income from any person, business entity or organization which currently receives or during the past two years received or applied for any grant reviewed, approved, administered or audited by the Department.
2. Any interest in residential real property located within the City of Los Angeles or not more than one half mile outside the boundaries of the City.
3. Any investment in or income from any person, business entity, or organization which owns (other than by mortgage or deed of trust) or operates residential rental property which is located within the City of Los Angeles.

CATEGORY 6

1. Any interest in real property located within the City of Los Angeles or not more than one half mile outside the boundaries of the City.
2. Any investment in or income from any person or business entity engaged in architectural or construction contracting in the City of Los Angeles.
3. Any investment or income from any person, business entity which sells or appraises real estate in the City of Los Angeles.
4. Any investment in or income from any persons or business entity engaged in providing financial and/or technical assistance to any business.
5. Any investment in or income from any financial institution which participates in a lending activity in conjunction with any grant or project reviewed, approved, administered or audited by the Housing Department.

CATEGORY 7

1. Any interest in real property located within the City of Los Angeles or not more than one half mile outside the boundaries.
2. Any investment in or income from any person or business entity engaged in architectural or construction contracting in the City of Los Angeles.
3. Any investment in or income from any person, business entity organization which currently receives or during the past two years received or applied for any grant reviewed, approved, administered or audited by the Department.
4. Any investment in or income from any institution which provides housing, rehabilitation services or materials in the City of Los Angeles.
5. Any investment in or income from any financial institution which participates in a lending activity in conjunction with any grant or project reviewed, approved, administered or audited by the Housing Department.

CATEGORY 8

1. Any investment in or income from any business entity which leases, sells or repairs business equipment, materials and supplies, including word processing and electronic data processing equipment and software systems.
