INFORMATION TECHNOLOGY AGENCY CONFLICT OF INTEREST CODE SCHEDULE "B" - DISCLOSURE CATEGORIES

GENERAL PROVISIONS

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee, or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

CATEGORY 1

- A. Any investment in, income from, or employment or management position with any person or business entity which:
 - 1. Is, is proposed to be, or within the past twelve months was, a telecommunications franchisee of the City or a competitor of such a person or business entity.
 - 2. Provides, proposes to provide, or during the past twelve months has provided financial or consulting services, to any of the City's current or proposed telecommunications franchisees, or to the City.
 - 3. Provides or proposes to provide communications or telecommunications services, or which manufactures, designs, constructs, sells, leases, installs, tests, or maintains telecommunications equipment, systems, assemblies, supplies, facilities, or services to the City of Los Angeles.
 - 4. Provides or proposes to provide television production studio equipment, television production consulting services, studio facilities, or studio services.
- B. Any investment in or income from any person or business entity which manufactures, designs, constructs, sells, leases, installs, tests, or maintains information technology hardware or software products, services, or supplies.
- C. Any investment in or income from any person or business entity engaged in the manufacture of components uniquely used in data information technology equipment.
- D. Any investment in or income from any person or business entity which markets information technology training services or management training services.

CATEGORY 2

Any investment in, income from, or employment or management position with any person or business entity which:

- 1. Is, proposed to be, or within the past twelve months was, a telecommunications franchisee of the City or a competitor of such a person or business entity.
- 2. Provides, proposes to provide, or during the past twelve months has provided financial or consulting services, to any of the City's current or proposed telecommunications franchisees, or to the City.
- 3. Provides or proposes to provide communications or telecommunications services, or which manufactures, designs, constructs, sells, leases, installs, tests, or maintains telecommunications equipment, systems, assemblies, supplies, facilities, or services to the City of Los Angeles.
- 4. Provides or proposes to provide television production studio equipment, television production consulting services, studio facilities, or studio services.
- 5. Any income from any individual who is or during the past twelve months was employed by the Information Technology Agency.
- 6. Any investment in or income from any person or business entity which manufactures, designs, constructs, sells, leases, installs, tests, or maintains information technology hardware or software products, services, or supplies.
- 7. Any investment in or income from any person or business entity engaged in the manufacture of components uniquely used in data information technology equipment.
- 8. Any investment in or income from any person or business entity which markets information technology training services or management training services.

CATEGORY 3

Any investment in, income from, or employment or management position with any person or business entity which:

- 1 Is, or is proposed to be, a telecommunications franchisee of the City.
- Provides, proposes to provide, or during the past twelve months has provided financial or consulting services, to any of the City's current or proposed telecommunications franchisees, or to the City of Los Angeles

CATEGORY 4

Any investment in, income from, or employment or management position with any person or business entity, as defined in this Code, which provides or proposes to provide communications or telecommunications services, or which manufactures, designs, constructs, sells, leases, installs, tests, or maintains telecommunications equipment, systems, assemblies, supplies, facilities, or services to the City of Los Angeles.

CATEGORY 5

Any investment in, income from, or employment or management position with any person or business entity which provides or proposes to provide television production studio equipment, television production consulting services, studio facilities, or studio services to the City of Los Angeles.

CATEGORY 6

- A. Any investment in, income from, or employment or management position with any person or business entity which provides, proposes to provide, or during the past twelve months has provided financial or consulting services, to any of the City's current or proposed telecommunications franchisees, or to the City of Los Angeles.
- B. Any investment in, income from, or employment or management position with any person or business entity which provides or proposes to provide television production studio equipment, television production consulting services, studio facilities, or studio services to the City of Los Angeles.
