**General Provision**

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee, or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

**Category 2**

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide environmental consulting service valued at \$1,000 or more for the Department of Airports.

Any investment in or income from any person or business entity which during the past 12 months used or proposed to use property owned or used by the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year was or proposed to be engaged in construction, maintenance or information technology services valued at \$1,000 or more for the Department of Airports as a contractor or subcontractor or any direct competitor of such person or business entity.

Any interest in real property which is within the jurisdiction.

**Category 3**

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide accounting services including investment counseling or financial auditing services valued at \$1,000 or more for the Department of Airports.

Any investment in or income from any person or business entity which during the past 12 months used property owned or used by the Department of Airports.

**Category 4**

Any investment in or income from any person or business entity which sells, leases, rents, or manages property, makes appraisals and title examinations on property, or which sells or purchases land, easements, licenses or land management services valued at \$1,000 or more involving property located on or within two miles of land which is owned or used by the Department of Airports.

Any interest in real property which is within the jurisdiction.

Any investment in or income from any person or business entity which during the past 12 months used or proposed to use Department of Airports property.

**Category 5**

Any investment in or income from any person or business entity which during the preceding completed calendar year supplied or proposed to supply materials, goods, or services valued at \$1,000 or more to the Department of Airports.

**Category 6**

Any investment or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide personal or management consulting services valued at \$1,000 or more to the Department of Airports.

Income from any individual who is currently employed, seeking employment, or during the preceding completed calendar year sought employment with the Department of Airports.

**Category 7**

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide services valued at \$1,000 or more involving the design, construction or maintenance or facilities for the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year was or proposed to be engaged in construction or maintenance services valued at \$1,000 or more of facilities on land owned or used by the Department of Airports as a contractor or subcontractor or any direct competitor of such person or business entity.

Any investment in or income from any person or business entity which during the past 12 months used or proposed to use property owned or used by the Department of Airports.

Any interest in real property which is located on or within two miles of land owned or used by the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year supplied or manufactured or proposed to supply or manufacture materials valued at \$1,000 or more for the use in construction or maintenance of facilities on land owned or used by the Department of Airports.

#### **Category 8**

Any investment in or income from any person or business entity which during the preceding completed calendar year was engaged in the construction or maintenance valued at \$1,000 or more of facilities which is on land owned or used by the Department of Airports as a contractor or subcontractor or any direct competitor of such person or business entity.

Any investment in or income from any person or business entity which during the past 12 months used property owned or used by the Department of Airports.

Any investment in or income from any person or business which during the preceding completed calendar year supplied or manufactured or proposed to supply or manufacture materials valued at \$1,000 or more for the use in construction or maintenance of facilities on land owned or used by the Department of Airports which are normally used in the occupational areas supervised or directed by the designated employee.

Any investment in or income from any person or business entity which during the preceding completed calendar year was engaged in the business of shipping or providing shipping related services valued at \$1,000 or more for goods which are or were transported through land owned or used by the Department of Airports.

#### **Category 9**

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide consulting



services valued at \$1,000 or more involving plans for use or property owned or used by the Department of Airports.

Any investment in or income from any person or business entity which during the past 12 months used or proposed to use property owned or used by the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year was or proposed to be engaged in the construction or maintenance valued at \$1,000 or more of facilities within land owned or used by the Department of Airports as a contractor or subcontractor or any direct competitor of such person or business entity.

Any interest in real property which is within the jurisdiction.

#### **Category 10**

Any investment in or income from any person or business entity which during the past 12 months provided or proposed to provide security services valued at \$1,000 or more for property owned or used by the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year was engaged in the business of shipping or providing shipping related services valued at \$1,000 or more for goods or passengers which are or were transported through land owned or used by the Department of Airports.

#### **Category 11**

Any investment in or income from any person or business entity which during the preceding completed calendar year was or proposed to be engaged in the business of shipping or providing shipping related services valued at \$1,000 or more for goods or passengers which are or were transported through property owned or used by the Department of Airports.

#### **Category 12**

Any investment in or income from any person or business entity which during the preceding completed calendar year supplied or proposed to supply information technology goods or services valued at \$1,000 or more to the Department of Airports.

#### **Category 13**

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide contracts or

leases for ground transportation services/vehicles or goods valued at \$1,000 or more to the Department of Airports.

**Category 14**

Any investment in or income from any person or business entity which during the preceding completed calendar year was or proposed to be engaged in the business of identification badging goods or services valued at \$1,000 or more to the Department of Airports.

Any investment in or income from any person or business entity which during the preceding completed calendar year provided or proposed to provide contractual services valued at \$1,000 or more to the Department of Airports.

**Category 15**
