**Schedule B – Disclosure Categories**

**General Provision**

A designated employee is required to disclose if he or she is a director, officer, partner, trustee, employee or holds any position of management in a business entity if he or she would be required to disclose income from that entity. The term "income" includes loans and gifts.

**Category 1**

Any investment in, income from, or business position with any person or business entity conducting business with or within the City of Los Angeles; any interest in, or income from real property located within the jurisdiction as defined by the Code.
