SCHEDULE "B" - DISCLOSURE CATEGORIES**

GENERAL PROVISION

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee, or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

CATEGORY 1

Any investment, interest in real property, or income as defined in this Conflict of Interest Code, except income from persons who are not residents in, do not own an interest in real property, and do not do business with or in the City of Los Angeles.

CATEGORY 2

- A. Any investment in, income from, or business positions with any person or business entity which currently holds or during the past 12 months held or sought a contract administered by the Department's of Public Work's Office of Community Beautification.
- B. Any investment in, income from, or business positions with any person or business entity which currently retails or wholesales graffiti removal-related equipment and supplies utilized by the Department of Public Work's Office of Community Beautification.
- C. Any investment in, income from, or business positions with any person or business entity engaged in preparing surfaces and mixing, matching, and applying paint and related material by brush, roller or spray gun to machinery, equipment, furniture, and the exterior of buildings and other structures.
- D. Any investment in, income from, or business positions with any person or which wholesales or retails trees and/or landscaping-related equipment and supplies.
- E. Any investment in, income from, or business positions with any community based, non-profit organization which provides, has applied to provide, or has submitted a bid proposal to provide services for the Department's of Public Works' Office of Community Beautification.

CATEGORY 3

- A. Any investment in, income from, or business positions with any person or business entity engaged in the acquisition, construction, installation, or maintenance of capital improvements, which include but are not limited to the restoration and preservation of City-owned buildings.
- B. Any investment in, income from, or business positions with any person or business entity which provides, has applied to provide, or has submitted a bid or proposal to provide architectural or construction services to the City of Los Angeles.

CATEGORY 4

Any investment in, income from, or business positions with any person or business entity which provides, has applied to provide, or has submitted a bid or proposal to provide public or media relations services, graphic design or printing services or supplies to the Agency.

CATEGORY 5

Any investment in, income from, or business positions with any business entity or individual who provides or seeks to provide personnel services for City agencies or employees. Such services include, but are not limited to, training, counseling, clerical and record keeping, employee relations, personnel research, employee rehabilitation, or services related to affirmative action, job analysis and examinations, or employee benefits.

CATEGORY 6

Any investment in, income from, or business positions with any person or business entity which provides accounting, auditing, management consulting, or other types of financial services utilized by the Department of Public Works.

CATEGORY 7

Any investment in, income from, or business positions with any person or business entity which retails or wholesales, maintains, repairs or installs, computer hardware, software, services or supplies.
