**GENERAL PROVISION**

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

**CATEGORY 1**

- A. Any investment in, income from, or business positions with any person or business entity which owns an interest in real property which:
  - 1. Is used for nighttime commercial business, or
  - 2. Has a front footage in excess of 100 feet, or
  - 3. Has nine or more usable units.
  
- B. Any interest in real property which:
  - 1. Is used for nighttime commercial business, or
  - 2. Has a front footage in excess of 100 feet, or
  - 3. Has nine or more usable units.
  
- C. Income from an individual who is, or during the past 12 months was employed by the Bureau of Street Lighting, or who applied for such employment during said period.
  
- D. Any investment in, income from, or business positions with any person or business entity involved in the design; preparation, checking or process of plans; manufacture, distribution, sale, installation, construction, repair or maintenance of street lighting systems components or equipment.
  
- E. Any investment in, income from, or business positions with any person or business entity which sells or leases technical supplies or equipment of the type utilized by the Bureau of Street Lighting.

**CATEGORY 2**

- A. Any investment in, income from, or business positions with any person or business entity involved in the design; preparation, checking or process of plans; manufacture, distribution, sale, installation, construction, repair or maintenance of street lighting systems components or equipment.
- B. Any investment in, income from, or business positions with any person or business entity which sells or leases technical supplies or equipment of the type utilized by the Bureau of Street Lighting.

**CATEGORY 3**

Any investment in or income from any individual or business entity involved in the design; preparation, checking or process of plans; manufacture, distribution, sale, installation, construction, repair or maintenance of street lighting systems components or equipment.
