REVISED CONFLICT OF INTEREST CODE
SCHEDULE "B" - DISCLOSURE CATEGORIES**

GENERAL PROVISION

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

CATEGORY 1

As required by State law (Government Code Section 87200), positions in this classification must disclose all investments, income, and interests in real property, or income as defined in this Conflict of Interest Code.

CATEGORY 2

Any investment, interest in real property, or income as defined in this Code.

CATEGORY 3

- A. Any investment in, income from, or business positions with any person or business entity which retails or wholesales:
 - 1. Paper, cardboard, illustration board, graphics, drafting equipment and supplies;
 - 2. Model construction material;
 - 3. Computer hardware, software or service;
 - 4. Printing and publications;
 - 5. Office equipment and furniture; and
 - 6. Contractual service.

- B. Any investment in, income from, or business positions with any person, school or employment agency which may provide personnel to assist in work and activities relating to planning and zoning in the City of Los Angeles.

- C. Any interest in real property on which any of the establishments set forth in Items A or B above are located.
