General Provision

A designated employee is required to disclose that he or she is a director, officer, partner, trustee, employee, or holds any position of management in a business entity if he or she would be required to disclose income from that entity. Income includes loans and gifts.

Category 1

All investments, income, and interests in real property located in, or doing business in the relevant planning area, or within 2 miles of its boundary.

Category 2

- A. Any interest in or income from any real property which has been declared, or is being considered or during the past twelve months was considered for declaration as an Historic-Cultural Monument by the Cultural Heritage Board.
- B. Any interest in or income from any real property, or investment in or income from a business entity, located on or adjacent to such a monument or proposed monument.
- C. Any interest in or income from any real property, or investment in, income from, or business positions with any person or business entity whose property has been proposed or which has been designated in a proposal to be included in a historic district overlay zone.

Category 3

All interests in real property located within the City of Los Angeles, as well as investments, business positions and sources of income (including gifts and loans.)

Category 4

All investments, business positions, and income (including gifts and loans) from sources that provide leased facilities, goods, equipment, computer hardware and software, or services, including training or consulting services, of the type utilized by the Department of City Planning.
