These rights include but are not limited to receiving an accusation, having the Commission members or an impartial administrative law judge hear the matter, personally appearing at an administrative hearing, confronting and cross-examining witnesses testifying at a hearing, and subpoenaing witnesses to testify at a hearing.
- 4. Barker understands and knowingly and voluntarily waives all rights to seek judicial review of any action by the Commission on this matter.
- 5. The exhibit that is attached and incorporated by reference is a true and accurate summary of the facts in this matter. Barker has violated the Charter as described in the Exhibit.
- 6. Barker will pay a total penalty in the amount of \$170,000 and in the form of a cashier's check payable to the "General Fund of the City of Los Angeles." The payment will be held by the Commission staff until the Commission members issue the order in this matter.

EXHIBIT

I. FACTS

Peter L. Barker is the president of Barker Management, Inc. (BMI), an Orange County-based property management and development firm. In the late 1990s, BMI began managing properties developed and owned by Advanced Development and Investment, Inc. (ADI), a Los Angeles-based affordable housing development company responsible for at least 16 projects in Los Angeles, many of which received City subsidies.

On March 3, 2011, the Los Angeles Times reported that ADI and its owners, Ajit Mithaiwala and Salim Karimi (Karimi), were being investigated by federal authorities for various crimes that were discovered during divorce proceedings between Karimi and his wife, including tax evasion and fraud. A court-appointed receiver in that case, David Pasternak, also found evidence of political money laundering in City elections. An investigation by City Ethics Commission (Commission) staff found evidence that ADI reimbursed many of its employees for political contributions made in their own names to City candidates and elected officials between January 1999 and December 2009. Commission staff noticed similar patterns of contribution activity among employees of other companies associated with ADI, including BMI, and the patterns raised questions about whether additional contributions had been reimbursed.

Between September 2000 and June 2012, Barker, his wife, BMI, and BMI employees and their relatives were reported to have made political contributions totaling \$71,300 to committees controlled by the following City candidates or elected officials: Kathleen Connell; Christine Essel; Eric Garcetti; Jose Gardea; Wendy Greuel; James Hahn; Janice Hahn; Nick Pacheco; Alex Padilla; Bernard Parks; Jan Perry; Eduardo Reyes; Herb Wesson; and Deron Williams. Attachment A contains a list of those contributions, grouped by the name of the supported candidate or officeholder.

Barker fully cooperated with the Commission's resulting investigation and admitted to Commission staff that he began to personally reimburse contributions made by BMI employees after an ADI representative threatened to terminate ADI contracts with BMI unless Barker satisfied specific political contribution fundraising requests. Barker said he complied with these requests by raising contributions from his employees and reimbursing his employees with cash from his own personal funds. After 2010, when ADI went into receivership, Barker began to receive solicitations for contributions directly from political candidates. In response to those solicitations, he continued to raise funds in the same manner, by personally reimbursing his employees for contributions made in their names.

Barker admits that, over an approximately 13-year period, he personally reimbursed 68 contributions, totaling \$41,600, made in the names of BMI employees Diane C. Bruce; Maria Castillo and her husband, Epigmenio Castillo; Linda Craig-Thorn; Kristina A. Graham, Roland I. Jones, Christopher Kolbenschlag, Maria G. Sanchez, and Karrie Valdez. Attachment B summarizes the reimbursed contributions Barker made in each of these employees' names.

II. APPLICABLE LAW

Campaign financing and disclosure in City elections are governed by the Los Angeles City Charter (Charter), the Campaign Finance Ordinance (Los Angeles Municipal Code §§ 49.7.1 et seq.), and the Political Reform Act (Cal. Gov't Code §§ 81000–91014).

Charter § 470(k) provides that "[n]o contribution shall be made, directly or indirectly, by any person or combination of persons, acting jointly in a name other than the name by which they are identified for legal purposes, nor in the name of another person or combination of persons." A "person" is "an individual, proprietorship, firm, partnership, joint venture, syndicate, business trust, company, corporation, limited liability company, association, committee, and any other organization or group of persons acting in concert." Cal. Gov't Code § 82047.

Violations of Charter § 470(k) circumvent the underpinnings of the City's laws regarding contribution limits. This type of violation is considered to be one of the most serious transgressions that the Commission enforces against, expressly because it undermines the public's important interests in limiting and knowing the sources of campaign contributions. Protecting these interests serves to "encourage a broader participation in the political process[,] avoid corruption or the appearance of corruption in city decision making, and ... promote accountability to the public" Charter § 470(a).

III. VIOLATIONS

Barker admits that he violated Charter § 470(k) by making assumed name contributions as follows:

COUNTS 1 – 68: MAKING ASSUMED NAME CONTRIBUTIONS

COUNTS 1 through 68: Between September 30, 2000, and June 26, 2012, Barker violated Charter § 470(k) by personally reimbursing BMI employees and others a total of \$41,600 for 68 contributions made in their names to numerous City candidates and elected officials, without disclosing the true source of the contributions.

IV. PENALTY

Charter \S 706(c)(3) establishes the penalty formula for administrative actions taken by the Commission: "up to five thousand (\$5,000) for each violation or three times the amount which the person failed to report properly or unlawfully contributed, expended, gave or received, whichever is greater." In this case, the maximum penalty ranges from \$124,800 (3 x \$41,600 in assumed name contributions) to \$340,000 (68 counts x \$5,000).

Los Angeles Administrative Code § 24.1.2(e)(7)(E) requires the Commission to consider all relevant circumstances before assessing penalties. In proposing the penalty in this case,

Commission staff noted the following mitigating circumstances: (1) Barker cooperated extensively with Commission staff by voluntarily providing detailed information, including information that the Commission otherwise may not have obtained; (2) Barker has saved significant Commission staff resources by entering into this stipulated settlement at an early stage in the investigation, prior to the preparation of a probable cause report; and (3) Barker has no prior enforcement history with the Commission.

Based on the specific facts and mitigating factors in this case, staff proposes a \$170,000 penalty. This penalty equals 50 percent of the maximum $(50\% \times $340,000)$ and is intended to reflect the serious nature of the violations while fostering cooperation with Commission investigations and the early resolution of violations.
