The undersigned is informed and believes that:

COUNT 1

On or about March 27, 2013, in the County of Los Angeles, the crime of KIDNAPPING-PC208(B)-SPEC ALLEG-VICT UNDER 14, in violation of PENAL CODE SECTION 207(a), a Felony, was committed by DANIEL MARTINEZ and TOBIAS DUSTIN SUMMERS, who did unlawfully, forcibly and by instilling fear, steal, take hold, detain, or transport any person from the County of Los Angeles, California, and did take the person from the County of Los Angeles County.

*SUMMERS has been arrested in the sexual assault of a 10-year-old Northridge Girl, kidnapped from her home after midnight.*
