During this period, all candidates, candidate controlled committees and committees primarily formed to support or oppose a candidate or ballot measure, that receive or make a late contribution, are required to file a late contribution report with the City Ethics Commission within 24 hours of receiving or making the contribution. Late contributions received by candidates are required to be reported again on the candidate’s next regularly filed campaign statement.
