Note: A candidate in the General Election must file a campaign statement for the *primary* election committee each time a statement is filed for the *general* committee. All candidates, even those not in the general election, must continue to file statements after an election on a semi-annual basis until their committees terminate.

* The period covered by any statement begins on the day after the closing date of the last statement filed, OR January 1 if no previous statement has been filed.

** The filing deadline of Thursday, November 26, 2009 has been moved to the next business day, Monday, November 30, 2009 due to the Thanksgiving holiday. The filing deadline of Sunday, January 31, 2010 has been moved to the next business day, Monday, February 1, 2010.

*** The Political Reform Act requires late contribution and late independent expenditure reports to be filed for the periods noted. Any late contribution or expenditure must also be reported on the subsequent campaign statement filed.
