<p>Municipal Legislation / Projects</p> <p>(1) 520 Mateo Project We reached out to Council District 14 for assistance with the developer of 520 Mateo to request support for a Project Labor Agreement for this development project.</p> <p>(2) 6901 Santa Monica Blvd Mixed-Use Project EIR [CPC-2015-4611-GPA-VZC-HD-DB-MCUP-WDI-SPR] I reached out to Council office 4 to request assistance in helping to set up a meeting with the developer of this project Onni Group. We wanted to sit down with the developer to attempt to convince them to hire Union Labor on this proposed project.</p> <p>(3) 8150 Sunset Project, 8150 W Sunset Blvd Spoke with Councilman David Ryu as well as Mayor's Office with regard to community benefits, or lack there of, related to the project.</p> <p>(4) California Water Fix, City Council Councilmembers Martinez and Ryu made a motion in the Energy, Climate Change and Environmental Justice Committee Opposing the MWD's proposal to fund the two tunnel option for the Bay Delta California Water FIX Project. I spoke to both offices to determine the nature of their opposition and any type of compromise they might have towards supporting the two tunnel option.</p> <p>(5) Chinatown College Station Project We reached out to Council District 1 Staff to request their assistance with arranging a meeting with the Developer of the Chinatown College Station Project.</p> <p>(6) CIPP Liner Contractor Inclusion, Public Works [N/A] There is a difficulty for signatory contractors to bid for work on sewer liner projects. We were seeking a resolution to this problem.</p> <p>(7) City Resolution in Support of AB 1000 [17-0002-S104] We lobbied the Council Members on the Rules Committee to either keep this item in committee or to vote against supporting it.</p> <p>(8) Commonwealth Ave & 6th St. ESDR CIPP Liner Installation Contract that originally went to one of Local 300's prime contractors as well as a Local 300 sub that was taken from the sub in error for failure to comply with the City's bid specifications. Local 300 just wanted to clarify that the sub contractor was in fact in compliance.</p> <p>(9) Construction Projects in Los Angeles, N/A [N/A] We are looking to have help from council members as it relates to construction projects in their districts and helping facilitate meetings with developers.</p> <p>(10) Enhanced Electrical Safety Policy, Public Works Lobbied the Board of Public Works, Contract Administration, the Mayor and Controller Offices to amend the policy as it relates to the awarding of conduit work for public works projects and allow for the work to be awarded to non electrical workers.</p> <p>(11) ESR List Opening, Public Works [N/A] Lobbied for two contractors to be added to the new list.</p> <p>(12) EV Infrastructure Training Program Met with the Mayor's Office to discuss the parameters of construction craft work related to this program.</p> <p>(13) FER-PAL/Aquapipe, Mayor's Office Reached out to Mayor's Office and Vice-President of Board of Public Works Heather Repenning to determine scope of meeting between FER-PAL with the Mayor's Office with regard to their meeting with Mayor Gracetti's Office.</p> <p>(14) ICON Project in Panorama City, LA City Planning Commission [VTT-74315-1A] Proposed mixed use, residential project being proposed for Panorama City in Council District 6. I reached out to the Council office to gain support from the developer to use Union Labor on the proposed project.</p> <p>(15) Incorrect Payment of Wages on Regional Connector The entity (RCC) that bid and is building the Regional Connector Project bid the project at the wrong prevailing wage rate for Laborers installing track and is paying the lesser wage rate currently.</p> <p>(16) Non-Payment or Inadequate Payment of Wages, N/A [N/A] We met with the City Attorney and his staff to discuss reporting a signatory contractor that is either not paying workers or paying inadequate wages on public projects.</p> <p>(17) Payment per 2.4.6.8 Rule</p>

BOE and Con Ad have repeatedly refused to acknowledge an agreement to pay Local 300 contractor's under the Laborer's Master Labor Agreement's 2,4,6,8 Rule. They would refer to the potential of an audit to refuse to pay. We met directly with Controller Galperin to determine whether audits were forth coming necessitating the stance espoused by BOE and Con Ad.

(18) Potential Pilot Project Utilizing Carbon Fiber [None Associated]

We are working with the City to have a pilot project created whereby the City uses a carbon fiber liner on a project to test it's integrity and understand its potential uses within the City and to be added to the approved list of products for the City.

(19) Prompt Payment Issue

We lobbied the Controller's Office, Board of Public Works and BOE to help resolve prompt payment issues for our ESR contractors.

(20) Proposed Super Dock, County of Los Angeles

Lobbying certain LA elected officials on approving the building of a Super Dock in the Port of LA or Long Beach and digging a goods tunnel all the way to the Inland Empire to move goods.

(21) South Hill Project

We reached out to Council District 14 for assistance with the Developer of the South Hill Project The Onni Group to discuss a potential Project Labor Agreement for their development.

(22) The Boring Company Tunnel, Transportation Committee [Council File 17-1342]

Lobbied the Mayor's office and Councilman Koretz's Office regarding construction of The Boring Company's proposed tunnel beneath part of Los Angeles from it's current portal in Hawthorne and construction workers being utilized to construct the tunnel.

(23) Utilization of Carbon Fiber Liner for Oil Lines in Los Angeles, Petroleum Administrator's Office

We met with City of Los Angeles Petroleum Administrator Uduak-Joe Ntuk to discuss lining of oil distribution lines running in Los Angeles for degradation and earthquake retrofit.
