OVER \$17.3 MILLION SPENT TO LOBBY CITY IN 2018-Q4

Entities registered to lobby City agencies reported receiving payments totaling over \$17.3 million in the fourth quarter of 2018, according to a summary on today's Ethics Commission agenda.

Reports filed by lobbying entities disclosed that clients paid a total of \$17,330,935 to lobby the City during the fourth quarter. Of the 2,041 clients registered for the fourth quarter, the ten who made the largest aggregated payments for lobbying services are listed in the Top 10 Highest Paying Clients table to the right.

Payments from these clients totaled \$2,474,373 and represented 14.3 percent of all payments by lobbying clients for the quarter.

The ten lobbying firms receiving the most client payments in the fourth quarter of 2018 are listed in the Top 10 Highest Paid Lobbying Firms table below. Together, these lobbying firms received a total of \$9,167,115, representing 52.9 percent of all client payments received in the fourth quarter.
